### Message from the President

WOW - It's been a very busy New Year planning, engineering and coordinating funding with local, state and federal agencies, obtaining FL-DEP permits and selecting contractors for Phase 1 of the oceanfront dune restoration. Finally

- Phase 1 is well underway!

Hurricane Matthew's high-wave action significantly eroded beachside dunes and damaged walkovers. Although Hammock Dunes did not experience community flooding, it is essential that we restore nature's "defensive sand dune barrier" to protect our community from future Matthewlike storms.

Phase 1 adds 70,000+ cubic yards of beach-compatible sand, plants new vegetation on the restored dunes and repairs all existing dune walkovers. We are projecting to complete Phase 1 in May. We are also coordinating with Flagler County and the State to fund, next year, a Phase 2 project that further enhances our oceanfront dunes and beach.

I want to personally thank David Eckert and his Matthew Recovery Team for their dedication and the many, many hours they have devoted to launch Phase 1, as well as their continued diligence to ensure its successful completion. Our February 17th Matthew Town Hall presentation provided complete details concerning Phase 1 of the restoration. I encourage all owners to go to HammockDunes.com, Current Property Owners tab, Hurricane Matthew Updates tab to view the Town Hall presentation.

Beach dune restoration is the HDOA Board's #1 priority. Our objective is for both current owners and potential new buyers to have the utmost confidence that Hammock Dunes remains the "Best Place to Live and Play".

The Finance Committee has been able to secure a loan to support the dune restoration projects. Effective April 1, 2017, the new dues rate of \$153.00 was approved by the Board. New coupon books will be mailed shortly. 2018 FY dues will be reviewed in Oct./Nov. 2017. Budget performance for 2016 FY was slightly above budget due to Hurricane Matthew. The Declarant and Development Committee (DDC) advises the HDOA Board regarding the future development of Hammock Dunes. In this capacity, the DDC developed a multi-year, time-phased Strategic Growth Plan for Hammock Dunes and, with Board approval, continues to implement key components of this plan.

Current DDC members are: George DeGovanni (Chair), Bruce Aiello (HDOA-Treasurer), George Bagnall, David Eckert and Mike Gill, with Travis Houk (SSMG) providing administrative support.

Recent accomplishments include:

- The Committee met with State and County elected representatives to petition for Federal and State funds to support post-Matthew community repairs and dune restoration.
- Supporting David Eckert and his Matthew Recovery Team by reviewing dune restoration plans, alternative sand dune engineered profiles and Phase 1 versus Phase 2 restoration scope and costs.
- Assisting HDOA Treasurer, Bruce Aiello, in evaluating FEMA, SBA and local bank funding sources and navigating the significant paperwork application process.

Since the last issue, preliminary approval has been granted on a new oceanfront home along Calle del Sur. Two roof replacements resulting from recent hurricane damage were approved as well as a garage addition on Island Estates, a pool and many landscape and other minor changes.

The Committee meets in the afternoon on the second Monday of every month. Members include consultants Bob Dickinson and Dave Mancino and community members Ada Abernathy, Cosmo DiPerna, Julie Gamble, Mike Gill, Mike Machin and Donna Trindle. Planning

The Hammock Dunes HDOA website (www.hammockdunes.com) continues to be upgraded to better market our community (thanks, Bill Conner). I recently had a preview of the type of information that can be obtained from the users of our website. Through the use of Google Analytics, information can be gathered that will be beneficial to realtors serving our community. Data has been collected since October of last year and includes (1) regions of the country from where we receive the most 'hits' (currently Florida, New York and Georgia) and exactly where in Florida (currently Palm Coast realtors) and the Orlando corridor), (2) the average time viewers spend on our site, and (3) in some cases, the type of information entered that would lead them to our site. After we gather more data, we may have better insight regarding improvements that we can make to our website to better market the community and provide better advice to the realtors serving the community.

The Dunes Community Development District has been granted a permit from the St. Johns Water Management District to expand the waste water plant from 500,000 gallons per day to 1,000,000 gallons. As of this article, the design is 60% complete, is out for bids and should be completed during the first half of 2018. In addition, the DCDD is in the process of completing the installation of a new Toll Collection System. By the time you receive this newsletter, you will have probably noticed that payment screen reflects the \$.50 that the your account is being charged rather than the old \$2. Obviously, this was not the purpose of the new system, but a side benefit of replacing the old system. The old system was having difficulties similar to what you might experience with a PC that you purchased 10 years ago.

The HDOA website (www.hammockdunes.com) continues to be improved under the watchful eye of Bill Conner. (many thanks, Bill!) with the guidance of Chris Austin at Tidal Technologies. The Real Estate Module now has over 100 listings with approximately 35 registered agents. Our site has improved its status and is typically ranking highly for searches with terms like 'oceanfront', 'golf' and 'Florida'. We will continue to work on optimizing this status.

**Maintenance**by David Yoder

Your HDOA Maintenance Committee has been quite busy since the last issue of *Inside The Gates*. We have helped the Dune Restoration Team with parts of their work in restoring our dunes.

Lighting of the new Hammock Dunes identification sign on Northbound A1A near our South Gate has been completed.

Concrete curb and sidewalk repairs have been underway both for safety and to keep our community looking great.

Island Estates will soon be getting a new light pole at the Mariners Drive entrance and fresh landscaping at their Main Gate.

Landscaping replacement and, in many cases, simplification to a more open and modern feel has been ongoing albeit at a slower pace than usual because of hurricane cleanup and restoration projects. Painting, replacement and maintenance of streetlights, street signs and landscape lighting is continuing. Streetlight poles are being replaced with reduced maintenance composite poles with LED street lighting.

From January 1, 2017 through March 20, 2017, there have been 16 property sales transactions in the Hammock Dunes Private Community. This includes 8 single-family homes, 5 condominiums, and 3 vacant lots. Currently, there are 18 properties pending or under contract; which includes 11 single-family homes, 5 condominiums, and 2 vacant lots. As of March 20, 2017, the active MLS listings are the following 37 single-family homes, 49 condominiums, and 34 vacant lots for sale.

Mike Gill was added to the HDOA Board last year. Mike, an attorney who recently retired from Accenture, serves as the Board's legal liaison with outside counsel involving the HDOA's legal matters. The HDOA uses local law firms as needed for recurring matters such as governance, contracting and collections. The HDOA has retained a firm with regulatory disaster recovery expertise to advise on HDOA's Hurricane Matthew recovery efforts.

Examples of legal matters reviewed include:

- Amendments to the governing documents to enhance collection efforts
- Amendments to the Design Review Manuals
- RFP and contract reviews
- Collection efforts
- Hurricane Matthew recovery strategies and filings, including those with State, County, FEMA and SBA authorities

## Enjoying Our Neighborhoods Safely!

Now that the trucks are rolling and the beach is closed for the dune restoration, it's a perfect time to explore the beauty and wildlife within our community.

Get out for a walk or a bike ride around the neighborhood. Maybe check out a neighborhood on the other side of the community. When you are out, please remember these safety guidelines.

As pedestrians, according to Florida statute 316.130, where sidewalks are provided, a pedestrian must not walk on the road, but should walk on the sidewalk. Some have said the blacktop is easier on the legs and knees, but the real answer is a good pair of shoes. Proper running or walking shoes will make all the difference.


Where sidewalks are not available, one may walk on the roadway. Remember to walk facing the oncoming traffic. Be alert and wear light-colored clothing, especially if you are walking early in the morning or at dusk.


Cyclists must also remember the rules of the road. In Florida, bicycles can legally be operated on all sidewalks (s. 316.2065). Of course, pedestrians have the right of way, and stop signs and crosswalks must be observed. When on the roadway, ride on the right side of the road in the same direction as the automobile traffic. When riding in the early morning or at night, be sure to have the proper white reflector or light in the front and red reflector or light on the rear of your bike.


Helmets are required by Florida law for those under 16 years of age and are recommended for all ages.

Remember: stay safe, be visible, stay alert and enjoy this beautiful Spring weather!










Crawler filling the dune
