Maintenance Committee Report

- The seven community bridges were inspected in November 2009 with no structural damage detected.

- Bicycle racks for Clicker Beach and Mariner Drive have been installed. A bicycle rack for the comfort station has been ordered and will be installed by the end of February.



- Fencing along Jungle Hut Road has been repaired with a stronger gage of fence. Fire Thorn Pyracantha shrubs will be installed along the interior of the fence, not visible from the golf course, to deter trespassers from entering the community through the golf course.

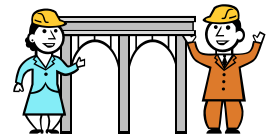
- The Main Circle Fountain will undergo an exterior refurbishment with cultured stone, bubblers, and a new acrylic finish.



- The Maintenance Committee is working with security and access control contractors to propose the installation and coordination of a wireless backbone for camera monitoring and integration for the Community.

- Lake bank and common property clearing of invasive plants and vines continues along the east and west side of Camino del Rey.

- The Camino del Mar bridge's stamped concrete will be sand blasted and re-stained. The balustrades and railing will be caulked, sealed, and painted.



- The geotechnical study and design for lake bank stabilization is complete. The Committee will meet with contractors familiar with the recommended product to discuss implementation along the Lake San Gabriel bank.

- An additional trash can was added on the beach for trash clean-up. The beach is inspected for garbage and loose debris twice a month.



- The Association is paving its portion of Avenue Royale in connection with Hammock Dunes Cub.

Security and Emergency Response (SER) Committee Report

Our new Access Control and Camera Systems continue to be a benefit to the community. All of the old "green" VAI (Vehicular Access Information) cards have been removed from the guard houses. As a reminder, new VAI cards are available on line at our website.

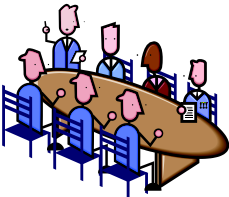
In January all "issued" smart passes were reviewed and a significant number of passes have been eliminated. Each owner is allowed up to three passes per resident/lot.

All residents are again urged to routinely secure their homes and vehicles and to look out for their neighbors. Suspicious activity should be immediately reported to the Flagler County Sheriff's Office by calling 911.



Incorporation Update

The Fact Finding Committee (FFC) has made the recommendation that the DCDD Board not seek incorporation at this time. The FFC found that incorporation of the DCDD land area was in fact feasible, and the survey showed significant interest by the residents. However, legal issues regarding transition of the DCDD's assets to the town could not be solved in the short term.



With this recommendation, the work of the FFC has been completed. I would like to thank the members of the FFC, DCDD Board and those residents who provided thoughtful opinions and information to the committee. *Submitted by Fred Gronbacher*

Unaudited 2009 calendar year financial statements of the Hammock Dunes Owners' Association, the Granada Estates Neighborhood Association and the Ocean Estates Neighborhood Association indicate that we are financially sound. In total we operated within budget, strengthened our reserves and had success with several cost saving initiatives.

We continue to pursue delinquent accounts with the assistance of legal counsel and are starting to see some delinquent accounts being resolved.



Just as a reminder, our HDOA monthly assessment is \$109 per month. The Finance committee thanks the other HDOA committees for continuing to operate within budget.

2010 Census

What You NEED To Know

It's Quick and Easy

The form asks for information about members of your household - name, gender, age, race / ethnicity, relationship to the householder, and whether you own or rent your home.

That's it! When you're finished, just put it in your mailbox. Be sure to return it by April 1st - Census Day. It's so easy, you can fill it out in a snap!

It's Confidential

Don't be afraid to be counted even if you are not a documented resident. Census forms are **COMPLETELY CONFIDENTIAL** for 72 years and cannot be shared with anyone, including welfare and immigration agencies, any court of law, and even the President of the United States. There are harsh penalties for anyone who discloses information that can identify a respondent or household.

It Brings Us Money

An undercounting of 1,000 residents could mean a loss of millions of dollars for Flagler County. Governments use census data to allocate billions of dollars in funding for education, public safety, housing, roads, public transportation, and other community services. It also determines representation in the federal and state legislatures. Census data helps attract new businesses and jobs to our community. Our census numbers stick with us for 10 years, so let's make sure **FLAGLER COUNTS!**

Mailing Your Form Means

No Visit At Your Door

The Census Bureau will only visit homes that **do not** mail back their questionnaires by April 1, 2010. If you complete and return your form by mail, a Census worker will not visit your home.
